2. Information about the project

ET Fuels and Vapo Terra Oy (later Neova), Neova Oy's wholly owned subsidiary, are striving to develop a 100-kilotonne green e-methanol plant in Finland and are considering Ranua as an investment location for a total investment of 800 million euros.

The entity will comprise a green e-methanol plant plus 300-500MW wind turbines and, potentially, solar power plant to support the plant's operations. The entity is designed to be located in the Ranua municipality region, surrounding properties owned by Neova and located in Näätäaapa. The project area comprises preliminary approx. 7600 hectares in total.

This is an integrated project, which means that the wind turbines and solar power plants would only be constructed in conjunction with the methanol plant. Additionally, the wind turbines will be implemented such that they are not connected to the national grid for electricity generation. This project would attract investments, a new kind of technical expertise, and sizeable financial resources to the area.

The project supports the Climate Neutral Finland 2035 target.

The project actors are evaluating several alternative locations for their projects in Finland, Spain, and the USA.

3. Purpose of the letter of support

The purpose of the letter of support is to express the support of Ranua's municipal board and council for the project's progression and to welcome the project actors to Ranua. The letter of support expresses Ranua municipality's support for the project and outlines measures to further the project.

4. Ranua municipality's support for the project and measures to further the project

- Ranua municipality's technical department will assist the project actors with the zoning process and progress through the zoning process as quickly as possible
- If necessary, Ranua municipality will initiate housing and office zoning that support the project by meeting the needs of the incoming workforce and corporate activities
- Ranua municipality will support the project actors in the process of dealing with environmental authorities by providing the necessary information and statements to authorities without delay
- Ranua municipality will support the project actors in discussions with the state administration, and contribute to ensuring that the project at hand is elevated to a nationally significant project
- Ranua municipality will support discussions and negotiations between the project actors, reindeer herders, and other stakeholders
- Ranua municipality and its subsidiary Ranuan Infra Oy will support the actors in all matters relating to the power network, water supply and district heating (process, schedule and costs)
